The 500 Delaware building has leased more than half its space with Kaczowka noting that he has other verbal agreements.

The largest tenants in the building are WSFS, the law firm of Morris James and the U.S. Postal Service's new downtown office.

The building has state-of-the-art features, including a lack of pillars. That aids in office design.
